This Statement of Privacy applies to the Heart 104.9 FM, Cape Town's beat! Web site and governs data collection and usage. By using the Heart 104.9 FM, Cape Town's beat! website, you consent to the data practices described in this statement.

Collection of your Personal Information

Heart 104.9 FM, Cape Town's beat! collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Heart 104.9 FM, Cape Town's beat! also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.
